DEFINITIVE REGISTRATION

NOMINATIVE REGISTRATIONS OF THE GYMNASTS AND OF THE OFFICIALS

This form has to be received by the UEG Secretariat by **August 16th, 2017** at the latest.

FIG LICENCE

All gymnasts must have a valid FIG licence which has to be presented upon accreditation.

ENTRY FEES

Euro 150.- per gymnast/per discipline.

According to the UEG TR, the inscription fee is 150.- Euro per gymnast for groups composed of 5 gymnasts. If a group has more than 6 gymnasts, the inscription fee is limited to 600.- Euro.

The event will be organised according to the valid TR/UEG (edition 2017) and the FIG Code of Points 2017-2020.

WORK PLAN

The participating federations will receive the work plan according to UEG regulations.

JUDGES

According to the TR/UEG, all Federations taking part in the competitions and having a judge with a valid FIG brevet must make him/her available for the competition (minimum 1, maximum 2 judges).

PUBLICITY ON THE ATTIRE OF THE GYMNASTS

Federations wishing to display advertising motifs on attires used in competition by gymnasts and/or coaches must notify the Secretariat of the UEG by completing the form "Publicity on competition attire" (available on the UEG Intranet). The form must be received at the Secretariat of the UEG not later than **August 16th, 2017**.
